

**Ordinance No. 2007-01**

**AN ORDINANCE TO ADOPT THE TOWN OF RANTOUL AND VILLAGE OF  
POTTER  
YEAR 2025 COMPREHENSIVE PLAN**

The Village Board of the Village of Potter, Calumet County, Wisconsin, does ordain as follows:

SECTION 1. In cooperation with Calumet County, and pursuant to Section 60.22(3) and 62.23(2) and (3), Wisconsin Statutes, the Village of Potter is authorized to prepare and adopt a comprehensive plan as defined in Section 66.1001(1)(a) and 66.1001(2), Wisconsin Statutes.

SECTION 2. The Village Board of the Village of Potter has adopted written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by Section 66.1001(4)(a), Wisconsin Statutes.

SECTION 3. The Village of Potter Plan Commission, by a majority vote of the commission recorded in its official minutes, approved a motion recommending to the Village Board the adoption of the document entitled "*Town of Rantoul and Village of Potter Expanded Land Use Element*" containing all of the information necessary for the Land Use element specified in Section 66.1001(2), Wisconsin Statutes.

SECTION 4. The Village of Potter has provided numerous opportunities for public involvement in accordance with the Public Participation Plan adopted by the Village Board including public informational meetings, Plan Commission meetings and a planning process web site. A public hearing was held on April 25, 2006, to review the Town of Rantoul and the Village of Potter Expanded Land Use Element.

SECTION 5. The Village Board of the Village of Potter adopted Resolution 2006-01 authorizing the distribution of the Town of Rantoul and Village of Potter Expanded Land Use Element as pursuant to Section 66.1001(4)(b), Wisconsin Statutes. The Town of Rantoul and Village of Potter Expanded Land Use Element references the "*Calumet County Year 2025 Recommendations Report*" and the "*Calumet County Year 2025 Inventory and Trends Report*" as adopted, to create the Town of Rantoul and Village of Potter Year 2025 Comprehensive Plan.

SECTION 6. The Village of Potter board held a second public hearing on October 17, 2007, to review the Town of Rantoul and Village of Potter Year 2025 Comprehensive Plan in compliance with the requirements of Section 66.1001(4)(d), Wisconsin Statutes.

SECTION 7. The Village of Potter Board does, by the enactment of this ordinance, formally adopt the Town of Rantoul and Village of Potter Expanded Land Use Element and hereby authorizes inclusion of the Town of Rantoul and Village of Potter Expanded Land Use Element in the County Plan. The Village of Potter Board also adopts the two county documents (including the "*Calumet County Year 2025 Recommendations Report*" and the "*Calumet County Year 2025 Inventory and Trends Report*") by reference, to create the "*Town of Rantoul and Village of Potter Year 2025 Comprehensive Plan*" pursuant to Section 66.1001(4)(c), Wisconsin Statutes.

SECTION 8. This ordinance shall take effect upon passage by a majority vote of the members-elect of the Village Board and publication/posting as required by law.
